Different thresholds for primary care shortages will yield different results.

An urbanized area consists of densely developed territory that contains 50,000 or more people. An urban cluster consists of densely settled territory that has at least 2,500 people but fewer than 50,000 people. Suburban areas are generally categorized as urban areas due to their population density. Rural areas consist of all territory, population, and housing units outside of urban areas and urban clusters.
